**CLEVELAND TRI-STATE CHARITY HORSE SHOW  
RELEASE OF LIABILITY**

I AGREE that neither the Cleveland Tri-State Invitational Horse Show, the Tri-State Exhibition Center, Bradley County, the State of Tennessee, Equine Sports Council, the show management nor the officials of the show, nor any affiliated or participating organizations, will be responsible for any accident, damage, loss or injury to mount, owner, rider or other persons or property. It will be the condition of entry that each exhibitor shall hold the horse show and it's management blameless for any loss or accident to any animal, person or property that may occur at the show. *Under Tennessee law, an equine professional is not liable for an injury to or the death of a participant in equine activities resulting from the inherent risks of equine activities, pursuant to Tennessee Code Annotated, title 44, chapter 20, part 1.* Limitation on liability for injury or death of participant except as provided in 44-20-104, an equine activity sponsor, an equine professional, or any other person, which shall include a corporation or partnership, shall not be liable for an injury to or the death of a participant resulting from the inherent risks of equine activities. Except as provided in 44-20-104, no participant or participant's representative shall make any claim against, maintain an action against, or recover from an equine activity sponsor, an equine professional, or any other person for injury, loss, damage, or death of the participant resulting from any of the inherent risks of equine activities.

Every Entry at a show affiliated with Equine Sports Council and run under Equine Sports Council's rules shall constitute an agreement and affirmation that the person making it, along with the owner, lessee, trainer, manager, agent, coach, driver, rider, and the horse: (1) shall be subject to the show rules; (2) that every horse, rider, and/or driver is eligible as entered; (3) that the owner and any of his representatives are bound by the show rules and will accept as final the decision of show management on any question arising under said rules, and agree to hold the Cleveland Tri-State Invitational Horse Show, Equine Sports Council, their officials, directors, and employees harmless for any action taken; (4) that the owner, rider/driver, and any of their agents or representatives agree to hold the Cleveland Tri-State Invitation Horse Show, Equine Sports Council, and their officials, directors, employees, and agents harmless for any injury or loss suffered during or in conjunction with the show, whether or not such injury or loss resulted, directly or indirectly, from the negligent acts or omissions of said officials, directly, from the negligent acts or omissions of said officials, directors, employees, or agents of the Cleveland Tri-State Invitational Horse Show or Equine Sports Council.
